Summary of Position:

As Paratek continues to expand and prepare for New Drug Application (NDA), developing and maintaining reliable business technologies supporting R&D functions is very important for the organization. Under direction the Vice President of Information Technology, this position is responsible for driving IT strategy, and delivery of IT services to the R&D functions – Clinical Development, Regulatory Affairs, and Quality function.
